- Kristi Dippel, Executive Director Clayton Improvement Association, introduced to
  the board the results of a survey conducted that identified a lack of affordable-long
  term rentals, reduction of school age population and the expansion of the elderly
  population that is stressing emergency services. Kristy is seeking to establish
  collaborative initiatives by the River Communities to begin to address these
  economic challenges to balance our tourist demands versus attractive year-round
  residents.
- Scott Burto, Planner has filed his monthly report which can be accessed in the review file, items included East End administrative close up and activities for Club Street project.
  - o Regarding the Strategic Plan, Mary Farrell has introduced conducting a resident survey versus Scott's initial plan of having a public working session.
